Camping Regulations – SOW 2026 – Morgins

1. Purpose

These regulations set out the conditions of use for the temporary campsites established for the Swiss Orienteering Week (SOW) 2026 in Morgins. Their purpose is to ensure participants' safety and comfort, while also protecting the environment.

3. Opening Period

Opening date: Monday, 6 July 2026
Closing date: Tuesday, 21 July 2026

Arrival and departure times will be specified at the time of booking.

4. Capacity and Areas

There are three designated sectors:

- **Val Joie:** motorhome pitches
- **Bellevue:** van pitches
- **Football field:** tent pitches

Estimated total capacity: approx. 200 pitches.

5. Fees (per night)

6. Booking and Payment

Bookings must be made via the online platform (link will be added once finalised).
Full payment is required at the time of booking to confirm your reservation.

7. Cancellation

Cancellations and modifications are allowed until the end of May.

8. Parking and Vehicles

Depending on the pitch booked, campers may park their vehicle on their pitch or in the designated car parks in Morgins.
Access routes and emergency lanes must remain clear at all times.

In the tent-only area, vehicles must be parked in the external car park; a drop-off zone (maximum 20 minutes) is provided for loading and unloading.

9. Facilities and Services

Permanent sanitary facilities will be supplemented by temporary toilets and showers.

Washing-up stations are provided.

A Euro-Relais service point is available for motorhome water supply and waste disposal.

No individual electrical connections are available for tents (a general charging point is provided).

Motorhomes and vans should bring a 30-metre extension lead.

10. Hygiene and Environment

Waste separation is compulsory (containers will be provided on site).

Pitches must be left clean on departure.

Littering is strictly prohibited. Any violations will incur a charge.

11. Safety and Fire

Open fires, charcoal barbecues, and fire pits are prohibited.

Gas stoves are permitted only on a stable surface, away from tents, and must be supervised at all times.

Please refer to the safety plan for further instructions.

12. Noise and Conduct

Quiet hours apply from 22:00 to 07:00.

Music is permitted at a moderate volume before 22:00.

Any disrespectful or violent behaviour may result in exclusion from the campsite.

13. Animals

Pets are not permitted in the tent area of the SOW 2026 campsite.

14. Responsibilities

The organisers accept no liability for loss, theft, or damage to personal belongings.

Campers are responsible for any damage caused to others or to campsite facilities.

15. Penalties and Final Provisions

Failure to comply with these regulations may result in a warning or immediate exclusion without refund.

The regulations are displayed at reception and are available online.

Any situation not covered by these regulations will be resolved at the discretion of the organisers.

By confirming a booking, the camper acknowledges and agrees to abide by these regulations.
